Enter your customer's tax information is done through Tmaxx unique data entry screen where all of your customers tax information are entered on one page, on one screen, on one tab. No need to navigate through multitude of tabs in order to complete your customer's return. All this information is entered in a centralized screen called the data entry screen. DT maxes one screen. Data entry is based on an interview based approach, meaning that the program asks you questions

you simply answer through what we call the keywords. The keywords can be found very easily through either features like the smart start where you're picking the sections that are relevant to your customers return, or by simply entering the keywords directly in the data entry. For example, entering slip numbers

or entering form numbers directly as your keywords.

What makes DT Max's data entry approach also unique are some of the features that are offered within them, allowing you to be more productive in producing your customer's tax return. For example, there is the right hand side display that allows you to compare in real time the data you entered in the previous year with the data you are entering in the current year. Not only do you have this as a comparative, you also have this as a data input tool. You could actually have the Tmax copy

over or import the information from one year to the next. Or for example from Autofill my return from the CRA
