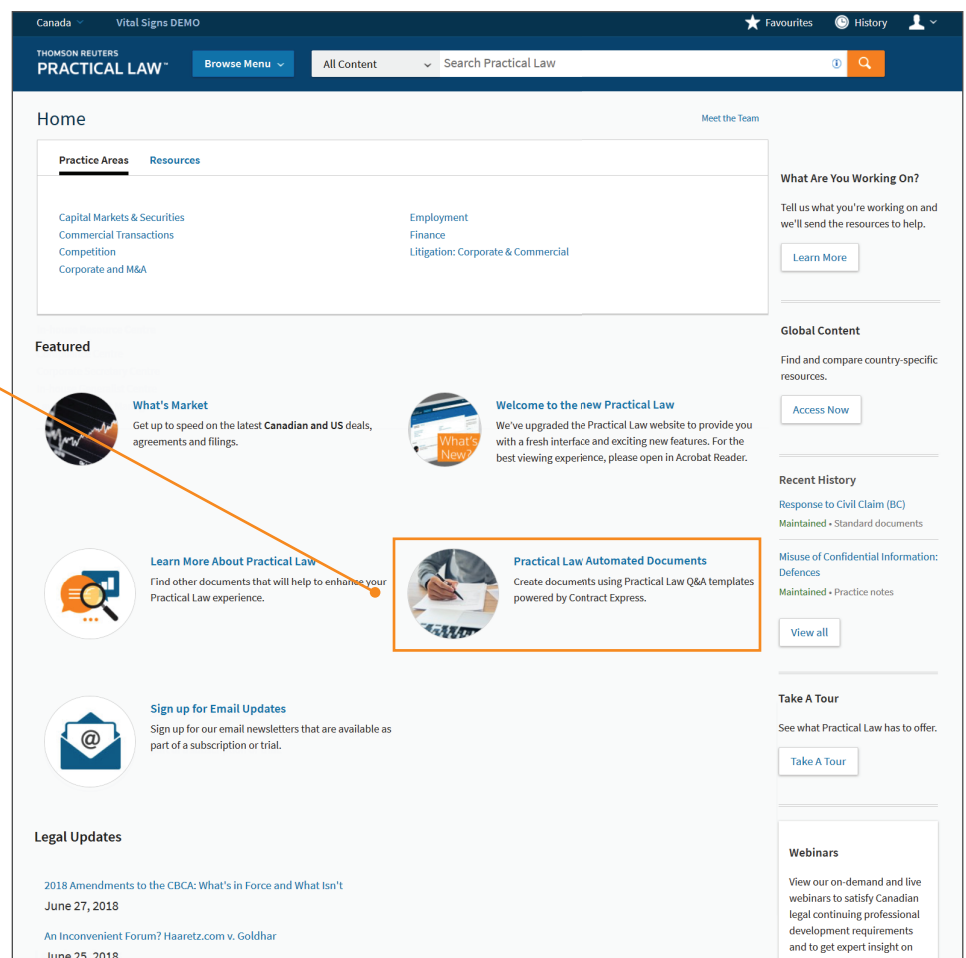

**Confidentiality and Non-Disclosure Agreement**

This Confidentiality Agreement (the "Agreement"), effective as of July 27, 2018 (the "Effective Date"), is entered into by and between XYZ Corp., a British Columbia limited partnership having its principal place of business at 123 Main Street, Vancouver, British Columbia, . . . , and . . . , Descriptor of Province or Territory . . . , having its principal place of business at . . . , Select Province or Territory, . . . (together the "Parties", and each a "Party").

WHEREAS, in connection with . . . (the "Purpose"), the Parties desire to share and exchange certain information that is non-public, confidential or proprietary in nature.

NOW, THEREFORE, in consideration of the mutual covenants, terms and conditions set forth herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

1. Definitions. For purposes of this Agreement, the following terms have the following meanings:

(a) "Confidential Information" means all non-public, confidential or proprietary information, data, documents, agreements, files and other materials disclosed before, on or after the Effective Date, by either Party (a "Disclosing Party") to the other Party (a "Recipient") or its Representatives, whether disclosed orally or disclosed or stored or accessed in written, electronic or other form or media, which is disclosed or otherwise furnished by the Disclosing Party or its Representatives to the Recipient or its Representatives in connection with the Purpose, including that portion of all analyses, notes, compilations, reports, forecasts, studies, samples, statistics, summaries, interpretations and other documents prepared by or for the Recipient or its Representatives which contain or otherwise reflect, are based on, or are generated or derived from in whole or in part such information, data, documents, agreements, files or other materials, whether or not marked, designated or otherwise identified as "confidential," including, without limitation:
