# Q: Will Practical Law Canada be automating further documents with Contract Express functionality?

**A:** This will be determined based on customer feedback on our launch collection.

#### Q: Who will have access to these documents?

**A:** Practical Law Canada users who subscribe to three or more modules will be able to access these documents. If a customer does not have a qualified subscription, they will not be able to access the automated version of these documents.

## Q: What if I don't buy three or more modules – can I still access these documents?

**A:** Yes. Customers can continue to access all documents within their subscriptions. However, they will not be able to access the automated versions of these documents.

## Q: If I only buy Contract Express, can I access these documents?

A: No.

## Q: Where can I access the Practical Law Automated Documents?

**A:** Practical Law Canada Automated Documents can be accessed via Practical Law. If you also subscribe to Contract Express, you can additionally access them via Contract Express. If you also subscribe to Drafting Assistant – Transactional, you can access them via Drafting Assistant.

# Q: Will my usage of automated documents be tracked on the usage report?

**A:** Yes. Our business intelligence tool will be enhanced to track your usage of automated Practical Law Canada documents.

#### Q: Where will the data reside?

**A:** Data that is inputted by Contract Express users when using Practical Law Canada Contract Express Automated Documents will reside on Canadian Servers.
